Log files

LOGIC GREEN uses log files by default. These files log visits to websites. All hosting companies do this and it is part of the analysis of the hosting services. Information collected in the log files includes internet protocol (IP) addresses, browser type, internet service

provider (ISP), date and time stamp, referring and exit pages and possibly the number of clicks. This data is not linked to personally identifiable information. The purpose of this information is to analyze trends, administer the site, track users' movements around the site and gather demographic information.

Cookies and web beacons

Like any other website, LOGIC GREEN uses 'Cookies'. These cookies are used to store information, including visitor preferences and the pages on the website that the visitor has accessed or visited. This information is used to optimize the user experience by customizing the content of our website based on the visitor's browser type and/or other information.
